

This document outlines some thoughts about future health services for the Dulwich area. We are seeking your views about those ideas.

Introduction

The 2009 Consultation exercise 'Transforming Southwark's NHS' identified a number of priorities for the development of better health services in the borough. We followed this up in 2010 with four public locality workshops where participants discussed more local issues around health and health services. Since then a number of projects in the borough have been completed, and now the NHS in Southwark is looking more closely at the Dulwich area.

From 8th February 2012 to the 11th May 2012 there will be a three month period during which we will be engaging the people of Dulwich in detailed discussions about the future shape of health services in their area. This will build on previous work and place it in a present day context. We want to get the best possible combination of health services to meet the needs of residents in the Dulwich locality.

We are aware that people do not easily follow neat boundaries so we are taking a flexible view on how we define the Dulwich area. This is so that we can include views from people who might live slightly further away but who might well choose to use services in the Dulwich area. Equally, local GPs serve patients from a wider area than just Dulwich.

Much has changed recently, and in particular GPs and other clinicians are now increasingly leading the commissioning of health services in Southwark, and they have agreed that they want a focus on the Dulwich locality as a priority.

These early discussions are about improving health and health services, so at this stage we are not asking specifically about buildings, the transport infrastructure, or the use of the Dulwich Hospital site. Later in the year there will be a formal consultation on how services should be provided and what buildings will be needed, once we have developed some more detailed options reflecting this period of engagement. This will include the future of the Dulwich Hospital site. If new or different buildings are needed to deliver services, we want to have developed a business case within eighteen months, and any completed building within three to four years.

Current context – so where are we now and what has changed?

In the 2009 consultation there was very clear support for improved services for the locality, based in a Health and Care Centre. However, since then a lot has changed – there is a different government with new health policies, a different council, an economic downturn, and there is huge pressure on public service budgets.

Most significantly, decisions about health services are increasingly made by GPs and their clinical colleagues, working as Clinical Commissioners.

In addition, some of the premises, including the existing Dulwich Hospital building, are in poor condition despite significant sums being spent on their maintenance over the past five to ten years. All health premises (including general practices) will be required to meet certain standards to ensure high quality services as part of their registration with the Care Quality Commission (CQC), the organisation that regulates health care providers, and some current local premises will struggle to do so. There are also some practices which do not have the space to expand as the population grows and the range of services they want to provide increases.

Current health services for the people of Dulwich

The Dulwich Locality is located in the south of the borough of Southwark, and is home to 75,000 people registered with over ten General Practices. The map on page 10 shows where those practices are located. Other primary care services are provided by pharmacists, dentists and opticians, operating from premises across the locality, and these too are located on the map.

Community services are provided in people's homes, in General Practices and at Dulwich Hospital, Townley Road Clinic and Consort Road Clinic – see table below.

Residents in the north of Dulwich also access some services outside the locality at the Lister Health Centre and Sunshine House, in the Camberwell/Peckham area.

People needing hospital services normally go to King's College Hospital, on Denmark Hill, which lies just outside the locality to the north-west.

The local Clinical Commissioners have reviewed service provision in the locality. They are concerned about the level of variability and would like to improve outcomes for patients. We also need to consider the distribution of primary care provision across the patch.

This is an opportunity to improve the range and quality of primary and community health services, and to explore how they can be improved through greater integration. This would improve patient experience and overall health outcomes. Local commissioners must also ensure services work well together and are affordable.

Summary of health status and needs of the local population

Dulwich, like the rest of Southwark, has a rich ethnic mix of people living in the area. It is less deprived overall than the rest of Southwark, although the area is very varied, with more affluence in the south and some pockets of significant deprivation in the north. There has been a very marked increase in the birth rate in the East Dulwich area.

Significant health issues for the locality are:

- Early (under 75 years) death rates in College, East Dulwich, Peckham Rye, South Camberwell and Village wards are similar to the England average.
 Early death rates are particularly high in Nunhead ward. For males, early death rates are also high in The Lane.
- The early death rate from cardiovascular disease is higher than the England average in the North East of the area – towards Nunhead, Peckham Rye and The Lane.
- Early death rate from cancer is high in two wards
 Nunhead and College.
- As elsewhere in the borough, there are many people with long term conditions (eg, high blood pressure, diabetes, coronary heart disease and chronic obstructive pulmonary disease).
- There are also many people with long term conditions that have not been detected yet (eg, high blood pressure and diabetes).
- As elsewhere in the borough, there is great variation between GP surgeries in the extent to which they achieve good treatment outcomes for their patients with long term conditions.
- In Southwark, there is projected to be an increase in the number and proportion of older people (65 years and older) living in the borough.







Building on the work we have already completed

In the 2009 consultation people across the borough supported the idea of more integrated services in the community, with enhanced primary and community services.

Respondents answering specific questions about Dulwich said they wanted access to the following services locally:

- Diagnostics including x-rays, scans and blood taking
- Community and social care services including mental health
- Services for people with urgent needs
- Management of long term conditions
- Comprehensive general practice provision/ primary care services
- Out-patients including ante-natal and post-natal care

People also said they thought that the following things were important to them:

- Prevention and early intervention
- Clinical Quality and Safety
- Easy appointment systems and convenient opening hours
- Accessible less travelling around for services
- Better communication with patients





As we are all aware, since 2009 there has been significant pressure on public sector funding. We will need to be assured that any changes are effective, represent good value, and that they are appropriate for local needs. In this context we also need to consider the following:

- 'Affordability', so we will have to look at the relative costs of services and where they are provided;
- Meet the needs of the local population, both in terms of capacity/quantity, and the kind of services required.
- Identifying ways of improving the efficiency of services and the patient experience, both through exploring the possible co-location of services and through avoiding duplication.

Finally, we are reviewing the strategy for intermediate care, and the outcomes of that review will feed into the plans for the locality. Intermediate care comprises a range of time-limited health and social care interventions for residents, often older people, to promote faster recovery from illness, unnecessary admission to and timely discharge from hospital, and to maximise their chances of remaining independent and in their own homes.



What do we want to talk to you about?

We specifically want to use this engagement to talk with you about the services you want to access at your – (or a neighbouring) – general practice or at a local centre or 'hub'. We want to show how the priorities you have identified are reflected in this service redesign.

We also want to talk with you about how some innovative and integrated services might be provided for the local population.

We want to make sure that the services we commission for the people of Dulwich represent the best combination within the resources we have.

So what are the ideas?

High Quality Primary and Community Health Services

General Practices

- A consistently high standard of service provision
- Prevention and screening systems and services e.g. immunisations, cervical screening and health checks
- · Long term conditions care
- Accessible and convenient services
- Premises that meet the required standards
- Good access to District Nurse and Health Visitor Teams

Other services which might be available at a neighbouring practice could be:

- Access to some simple diagnostics eg Blood taking (phlebotomy) where this is affordable and will improve patient experience
- A wider range of clinics

Integrated ante-natal, postnatal and first year of life care – in response to the increasing number of young adults in the area

- There is a high birth rate in East Dulwich, with increasing demand for services for young families
- There is the potential to develop an integrated midwifery/health visiting service providing a range of support and advice to women during pregnancy and while their babies are small (eg breastfeeding).
- This could be a service for well women during their pregnancy and well children offering clinical oversight, support and advice up to a child's first birthday and would improve accessibility for local patients
- It would not duplicate the specialist services offered from Sunshine House
- There would be the potential to develop supportive relationships with patients over a period of time

Services for people with urgent care needs

- General practice remains the provider for the vast majority of urgent needs that do not require a trip to hospital, provided they are accessible.
- More serious illnesses and injuries require a wider range of expertise and diagnostics, so the current plan is that urgent care will be located alongside A&E departments or where there is diagnostics and the right medical backup. Modern digital x-ray facilities are available at Kings and Guys and St Thomas and are able to undertake the widest range of images of all levels of complexity.
- SELDOC provides GP out-of-hours services to the residents of Lambeth, Southwark and Lewisham, and their main base is at Dulwich Hospital. We are currently developing Urgent Care Centres across Lambeth Southwark and Lewisham which will be located alongside existing A&E departments or Minor Injury Centres. These will be at King's, Lewisham, Guy's and St Thomas'. We will need to consider the implications of the service SELDOC provides in the light of these changes. Although convenient for local residents, it is less easy for people from further away to get to. There is evidence to say that locating primary care alongside Urgent Care Centres and A&E departments will improve overall services to patients.

Services in support of primary care, and for people at home

There are a range of services which if provided locally would enable more people to stay out of hospital and would support their GPs in looking after them. Elsewhere in the UK there are some good models we can explore.

Some ideas we are keen to get your views on are:

An Integrated Long Term Conditions (LTC) Service (diabetes, heart disease, respiratory/lung disease)

- There are an increasing number of people with long term conditions which need ongoing monitoring and care;
- Co-locating a number of LTC services could provide better services for the increasing number of people with more than one condition
- LTCs are increasingly managed in primary care with specialist input where required.
- Local services could improve accessibility for patients, with potentially shorter waiting times
- This service could be supported by some diagnostics – eg lung function tests, Electrocardiograms (ECGs), and blood testing;
- An integrated service could provide 'one stop shop' support for this group of people by allowing them to access services in one place, and to access a range of additional services. This could include physiotherapy, Occupational Therapy and equipment stores, nutrition support, social support etc.
- These could be very valuable for a group of people who are often less mobile
- The support services could also provide support to Intermediate Care services provided locally
- A local service could liaise better with local practices

Out patients

- There are currently a few out-patient services located in community settings in Southwark (Headache, Dermatology (skin) complaints and ENT (Ear Nose and Throat) clinics).
- However, there is a real opportunity for the provision of clinics related to long term conditions (eg heart and lung disease, diabetes).
- There may be other opportunities as well, particularly for those specialties which do not require complex or high cost equipment found in hospitals
- Out-patient services which do need complex or high cost equipment for examination and diagnostics are often not cost effective to provide in smaller units.
- We currently have direct access to ultrasound provided in the community, and this could be provided in the Dulwich area. However, we need to be certain that direct access from general practice to diagnostics improves the patient pathway and represents good value.

Elderly Care services

- The Betty Alexander Service has moved to King's College Hospital where it is close to a range of diagnostic and treatment expertise;
- However, for people needing less intensive or on-going care, there is the potential to align existing services (eg physiotherapy and occupational therapy) more closely with long term services and the intermediate care / rehabilitation services. Patients could then access a similar group of therapies.
- Dulwich Helpline is a voluntary sector organisation which provides volunteer befrienders to people who are frail and elderly. They run both groups and one-to-one support. This service might sit well alongside services for older people and those with long term conditions.

Services in people's homes

Some district nursing and health visiting services are provided in people's homes.

We want to extend the services provided in people's homes, and have recently invested £2.3m to provide intermediate care services for the population of Southwark:

Intermediate Care – a time-limited range of health and social care services mainly for older people which aim to:

- Promote faster recovery from illness
- Prevent unnecessary admission to hospital
- Support timely discharge from hospital
- Prevent premature need for long term residential care
- Maximise the chances of remaining independent.

They include - existing services:

- Rapid response rapid health and social care assessment and access to short term support to help them stay at home instead of being admitted to hospital
- Short term rehabilitation in a residential setting for people no longer requiring 24 hr access to consultant medical care
- Support for people coming out of hospital
- Neuro-rehabilitation team providing support for people after strokes and other longer term neurological conditions
- Adult Community rehabilitation support for people after they have had a fall.

And new services:

- Virtual ward multidisciplinary teams working in the community to prevent emergency admissions to hospital. They focus on the most vulnerable and frailest people in the community and is currently being piloted in North Southwark and South Lambeth.
- Enhanced stroke care six month review
- Enhanced rapid response
- Enhanced social care response fast track reviews and support packages, including handyperson support and 'blitz' cleans

Other services currently available locally There are also some other services currently provided locally:

Renal Dialysis

King's College Hospital have confirmed that the unit at Dulwich Hospital is very busy, and that they will be want to continue to provide this service locally in the Dulwich Locality.



What opportunities are there for you to be involved?

We are keen to talk to as many people as possible. If there are any groups you belong to who would like to discuss these ideas we would be happy to come along.

We will be running discussion groups and there will be a public meeting towards the end of April.
