Results of quality monitoring project: executive summary

North Birmingham CHC, 15 pages

Report of one of three quality monitoring projects undertaken by Birmingham CHCs. For this survey 105 patients responded, 27 observation visits were made, 27 questionnaires were completed by ward managers and 37 questionnaires were completed by ward staff.

Report on community health services for young people with learning disabilities in North Tyneside

North Tyneside CHC and the Learning Disability Federation, 18 pages

50 questionnaires were sent out to carers of children at two special education nurseries and to carers of children under five years old who are on the Learning Disability Federation mailing list. 13 were returned (26% response rate). The questionnaire covered: personal/carer information; child care clinics and learning disability; entitlements to other services; and parents/carers views of specialised services.

Information and choices in maternity care

South Cumbria CHC, 32 pages

Questionnaires were distributed to women attending antenatal clinics and to their partners. Of 94 questionnaires given out to women, 88 usable questionnaires were returned; of 44 handed out to men, 37 usable questionnaires were returned. The questionnaire covered contact with professionals and the adequacy of discussion, information and choices during pregnancy and about delivery.

A journey to care

A study of the views of people using community services and their carers on assessment and care management

Oxfordshire CHC, 78 pages

The major objective of this study was to evaluate both the process of assessment and care management and the outcomes for people who use services and for their carers. Questionnaires were completed during interviews with 123 people contacted through social services. The researcher also 'shadowed" care managers on their duties. Most of the cases involved cannot be presented in the report because of confidentiality considerations, but a case study which the researcher followed up throughout the study period is given in full.

A report on palliative care services for the residents of North Tyneside

North Tyneside CHC, 22 pages

A report compiling information on the range, type and sources of help available for people needing palliative care. An introductory section on sources of help is followed by three visit reports and contact details for services and voluntary organisations.

Survey of GP opinions on current alcohol services

Manchester South CHC, 6 pages

This survey was prompted by the Manchester Health Authority's Purchasing Plan in relation to alcohol services and by concerns for the future of the Withington Hospital Alcohol Treatment Unit. Questionnaires were received from 30 GPs (31% response rate). The CHC intends to use the findings when it responds to the next Manchester Health Authority Purchasing Plan.

Discharge procedures

Patient satisfaction survey

South Buckinghamshire CHC, 17 pages

Questionnaires were sent to 100 patients whose discharges had already been audited by the South Buckinghamshire NHS trust so that the results from both surveys could be compared. 55 patients responded. Generally day surgery patients had received better/more complete verbal and written information than inpatients.

Support and information available to women with breast cancer in Newcastle upon Tyne and North Tyneside

A report of women's views

Newcastle CHC, 42 pages

A report presenting women's views of the support and information they received from the time they were told that they had breast cancer and during their treatment and subsequent care. Information was gathered from a literature search, focus groups with services users, discussions with breast care nurses and consultants and from cancer support agencies.
